### BoundCon Terms and Conditions

#### § 1 Registration

1. Registration can only be made using the organizer's PDF or online registration form.
2. Registration is binding. The organizer decides on admission (§ 3).

#### § 2 Inclusion and acknowledgment

By registering, the registrant accepts the terms and conditions of participation, any "special trade fair, festival, and exhibition conditions," and the technical guidelines of the organizer as binding for themselves and all persons employed by them at the trade fair. These regulations thus become part of the contract between the exhibitor and the organizer.

#### § 3 Admission

1. Only those whose stand and exhibition content correspond to the organizer's trade fair/convention concept can be admitted as exhibitors. The organizer may restrict individual stand space for objectively justified reasons, in particular if the space available is insufficient. In the case of obviously copied goods/designs, the organizer will decide individually on admission to the trade fair.
2. The contract between the applicant as exhibitor and the organizer is concluded upon written confirmation of admission. Admission will only be granted if the partial payment due after registration (50% of the invoice amount) has been paid within 30 days of receipt of the registration. Admission may be revoked if the conditions for its granting were not met or have subsequently ceased to exist.

#### § 4 Reservation of subsequent changes

1. In the event of unforeseen circumstances that make it impossible to hold the trade fair/convention as planned and for which the organizer is not responsible, the organizer is entitled to postpone, shorten, extend, or temporarily close or cancel the trade fair/convention in whole or in part. Claims by exhibitors, regardless of their legal basis, in particular for damages and reimbursement of expenses, are excluded. If the trade fair has to be closed due to force majeure or by official order, the exhibitor shall owe the agreed stand rental and all other costs to be borne by him in full.
2. In the event of a postponement, exhibitors may demand cancellation of the contract if they can prove that the new date clashes with another trade fair that they have already booked. They shall only be required to reimburse costs incurred at their own initiative.
3. In the event of a shortening or only temporary closure of the trade fair, the exhibitor shall have no claims.

#### § 5 Withdrawal by the exhibitor

1. If cancellation is made by February 28, 2025, the exhibitor will be refunded the full amount of the invoice paid up to that point. For cancellations between March 1, 2025, and May 1, 2025, the organizer will charge 25% of the agreed stand rental fee, including flat rates, as a contribution to costs. In the event of later cancellations, the full invoice amount shall be due. The exhibitor shall also bear any additional costs incurred at the exhibitor's request.
2. Withdrawal requires a written application. It shall only become effective once it has been accepted in writing by the organizer.

#### § 6 Stand allocation

1. The stands will be allocated by the organizer, taking into account the event concept and the theme specified by the trade fair/convention.
2. Until the hall plan is drawn up, the organizer will endeavor to take into account the exhibitor's wishes regarding the form and location of the stand. However, there is no entitlement to this. After that, the stands will be allocated according to availability.
3. The stand allocation will be communicated in writing no later than 4 weeks before the trade fair.
4. The organizer is entitled at any time to relocate the entrances and exits to the exhibition grounds as well as the emergency exits and passageways in the halls for compelling reasons.

#### § 7 Subletting

1. The exhibitor is not entitled to sublet or otherwise transfer all or part of the stand allocated to them, to exchange it or to accept orders for other companies without the organizer's consent.
2. In the event of transfer to third parties not approved in the admission, the organizer is entitled to demand that the subtenant vacate the stand, whereby the exhibitor's obligation to pay rent remains unaffected.

#### § 8 Joint stands

If several exhibitors jointly rent a stand, each of them shall be jointly and severally liable. They must name a joint representative in the registration form. This representative shall be authorized to make and accept all kinds of legal declarations on behalf of the exhibitors.

#### § 9 Rent, costs, terms of payment

1. Stand rental fees and surcharges are specified in the registration form or in any "special trade fair, convention, and exhibition conditions." The exhibitor shall bear any additional costs for additional orders or other ancillary services.

2. The invoice amount plus statutory VAT is due in accordance with the payment terms stated on the invoice.
3. The issuer's right to offset and retain payment is excluded, unless there are undisputed or legally established claims.
4. In the event of futile payment reminders and a corresponding written warning with a final payment deadline, the organizer is entitled to terminate the contract with immediate effect.

### § 10 Right of termination of the organizer

1. The organizer is entitled to terminate the contract without notice if there is an important reason. Such reasons include, in particular, that
  - a) The exhibitor is in default of payment and does not make payment within one week of receiving a reminder.
  - b) The exhibitor disturbs other exhibitors or the operation of the trade fair or fails to comply with the instructions or house rules of the organizer.
  - c) The trade fair/exhibition does not take place in whole or in part, notwithstanding § 4.
2. Termination must be made in writing. The organizer may demand minimum damages of 50% of the agreed stand rental fee (lump-sum compensation). The assertion of greater damages is not excluded. The exhibitor is free to prove that the organizer incurred less damage than claimed.

### § 11 Design, equipment

1. The exhibitor must construct the stand in a sufficiently stable manner, including rear and side walls. The organizer will provide the necessary walls, which are included in the stand rental fee.
2. If the exhibitor does not require these walls and brings their own complete stand, the stand rental fee is reduced to EUR 30.00 per m<sup>2</sup> (excluding flat-rate ancillary costs).
3. In the interests of a successful overall presentation, the organizer's guidelines and instructions must be followed during construction and furnishing.
4. The organizer may demand that stands whose construction has not been approved or which do not comply with the exhibition conditions be changed or removed. If the exhibitor does not comply with the written request within 24 hours, the organizer may arrange for the removal or alteration at the exhibitor's expense. If the stand has to be closed, the exhibitor shall have no claims.

### § 12 Operation of the stand

1. During the opening hours of the event, the stand must be stocked with the registered goods, staffed with sufficient information personnel, and kept accessible to visitors. Premature dismantling of the stand is not permitted and may be punished with a contractual penalty.
2. The operation of loudspeaker systems, music/light shows, the demonstration of machines, devices, and equipment of any kind, as well as similar activities, require the written permission of the organizer. Even a permit that has already been granted may be restricted or revoked in the interest of maintaining proper trade fair operations.
3. The exhibitor is responsible for disposing of their own waste! The statutory regulations must be observed when disposing of waste.

### § 13 Exhibitor passes

The following exhibitor passes are included in the stand rental fee:

For stand sizes up to 10 sqm: 2 exhibitor passes  
For stand sizes up to 20 sqm: 3 exhibitor passes  
For stand sizes over 20 sqm: 4 exhibitor passes

Additional passes can be ordered at a price of €21.00 plus 19% VAT (= **€25.00** per pass). However, **a maximum of 8 additional passes** can be ordered **per stand**. These passes are valid for all 3 days of the trade fair. The passes will be issued during setup in our trade fair office in the entrance area of the hall and must be collected there by all exhibitors themselves. Without a pass, you will not be admitted to the hall on the trade fair days!

### § 14 Advertising

Advertising of any kind, in particular the distribution of advertising material, but also the addressing of visitors, is only permitted within the stand without the express permission of the organizer.

### § 15 Direct sales, catering

1. The direct sale of goods to third parties is permitted.
2. Catering, in particular the sale of food, beverages, refreshments, luxury foods, and foodstuffs of all kinds, is not permitted to exhibitors.

### § 16 Photography ban

Filming is generally prohibited at the trade fair.

Photography is prohibited outside the specially marked areas on the entire Boundcon premises. Exceptions are specially marked and indicated with a traffic light system.

Photographs may not be used for commercial purposes. The use of flash and continuous lighting is prohibited.

Uninvolved persons and visitors who have not explicitly consented to this photo shoot may not be photographed or visible in the background.

Beyond the stage, ALL persons photographed must actively consent to being photographed.

Boundcon employs its own photographers and videographers, who are identified as such by T-shirts and/or badges. They are tasked with documenting the trade fair and stage events. For this purpose, they are permitted to take photographs anywhere without restriction.

Guests and/or visitors will only be shown recognizably by our employees with their express consent.

### § 17 Fire protection

Only flame-retardant materials may be used for stand decoration. Open flames are prohibited at the stand.

### § 18 Cleaning

The organizer is responsible for cleaning the aisles and exhibition areas at night. Exhibitors are responsible for cleaning their own stands.

### § 19 Parking

Paid parking spaces are available for exhibitors directly at the exhibition grounds.

### § 20 Security

1. The organizer is responsible for general security in the halls and on the outdoor grounds, but accepts no liability for loss or damage. Security begins on the first day of setup and ends at the end of dismantling.

2. The exhibitor is responsible for supervising and guarding their stand. This also applies during the set-up and dismantling times.

### § 21 Liability, insurance

The organizer accepts no liability for damage to exhibition items, stand equipment, or any consequential damage, unless the organizer is responsible for such damage due to intent or gross negligence. The organizer has taken out liability insurance for its legal liability, which covers only damage to third parties (trade fair visitors).

Exhibitors, their personnel, and their property are not included. Exhibitors are strongly advised to insure their exhibition items at their own expense.

### § 22 House rules

1. The organizer exercises domiciliary rights on the entire exhibition grounds during the set-up, running, and dismantling periods of the trade fair. He is entitled to issue instructions in general and in individual cases or to issue special house rules.

2. The exhibitor and its staff may enter the exhibition grounds during the exhibition period one hour before the start of the exhibition and must leave the grounds no later than one hour after the end of the exhibition. Overnight stays on the grounds are prohibited.

### § 23 Forfeiture, limitation period

1. Claims by the exhibitor against the organizer arising from and in connection with the stand rental agreement shall be deemed forfeited if they are not asserted in writing within one week of the end of the fair at the latest.

2. In all other respects, all claims of the exhibitor and its employees against the organizer shall become statute-barred within six months of the end of the trade fair/exhibition.

### § 24 Ancillary agreements, amendments

Any deviations from these Terms and Conditions of Participation, the admission requirements or, where applicable, further "Special Terms and Conditions for Trade Fairs, Festivals and Exhibitions" or Technical Guidelines must be made in writing in order to be valid. Verbal side agreements are not valid. This also applies to the waiver of the written form requirement.
